AND SCHOLARSHIP PROGRAMS  
FISCAL YEAR 2019**

# Executive Summary

The Nurse Corps Loan Repayment and Scholarship Programs Report to Congress for Fiscal Year (FY) 2019 is in response to section 846(h) of the Public Health Service Act, which states, in part:

*Not later than 18 months after the date of enactment of the Nurse Reinvestment Act, and annually thereafter, the Secretary shall prepare and submit to the Congress a report describing the programs carried out under this section.*

The goal of many Health Resources and Services Administration (HRSA) programs is to support the delivery of health care in areas of greatest need. HRSA administers the Nurse Corps Loan Repayment Program (LRP) and Scholarship Program (SP) to improve the distribution of nursing graduates and professionals. The Nurse Corps LRP and SP support nursing education and training by providing recruitment and retention incentives to nurses committed to a career in underserved communities. These incentives include either a loan repayment or a scholarship award in exchange for service in a health care facility with a critical shortage of nurses (Critical Shortage Facility or CSF) that is located in a Health Professional Shortage Area (HPSA). The Nurse Corps LRP also extends loan repayments to nurse faculty serving in accredited schools of nursing.

In FY 2019, the Nurse Corps received \$86.7 million from annual appropriations. The Nurse Corps LRP received 4,894 new and continuation applications and the SP received 2,170 new and continuation applications. HRSA made a total of 1,079 new and continuation Nurse Corps awards (853 LRP, including 142 Nurse Faculty LRP, and 226 SP) to nurses and nursing students across a total of 48 states, the District of Columbia, and Puerto Rico. Of the 853 new and continuing Nurse Corps LRP awards, 711 were made to participants serving at CSFs—98 percent at CSFs in high-need HPSAs (high-need HPSAs are defined as areas with a score of 14 or higher). The average HPSA score for the FY 2019 CSF placements was approximately 17. HRSA made 142 Nurse Corps LRP awards to nurse faculty participants—18 percent serving at schools of nursing with at least a 50 percent enrollment of students from disadvantaged backgrounds. Nearly 68 percent of SP awards were awarded to bachelor's degree students, 27 percent to master's degree students, 5 percent to associate's degree students, and 0 nursing diploma students.

As of September 30, 2019, the Nurse Corps field strength included 1,928 registered nurses (RNs) and nurse faculty members fulfilling multi-year service commitments. Further, 84 percent of Nurse Corps alumni remained at a CSF for up to 2 years beyond the completion of their Nurse Corps service commitment.

## I. Statutory Language

Section 846(h) of the Public Health Service Act (PHS) requires that the Secretary provide a report to Congress. The PHS Act states, in part:

*Not later than 18 months after the date of enactment of the Nurse Reinvestment Act, and annually thereafter, the Secretary shall prepare and submit to the Congress a report describing the programs carried out under this section.*

## II. Introduction

The Health Resources and Services Administration (HRSA) administers the Nurse Corps Loan Repayment Program (LRP) and Scholarship Program (SP) to improve the distribution of nursing graduates and professionals.

The Nurse Corps LRP is a financial incentive program in which registered nurses (RN) and advanced practice registered nurses (APRN), such as nurse practitioners (NP), enter into a contract with the federal government to work full-time in a Critical Shortage Facility (CSF) with a critical shortage of nurses.<sup>1</sup> The LRP repays 60 percent of the outstanding principal and interest on the nursing education loans for participants with the greatest financial need in exchange for a 2-year service commitment. Participants may be eligible for an additional 25 percent repayment in exchange for an optional third year of full-time service.

The Nurse Corps LRP also makes awards to nurses to serve as faculty at accredited schools of nursing with a preference given where at least 50 percent of the students are from a disadvantaged background. The awards aid in the recruitment and retention of nurse faculty by decreasing economic barriers associated with pursuing a career in academia. Nurse faculty receive the same loan repayment benefits as program participants serving at a CSF. To become nurse faculty an RN must continue training and assume additional financial and time commitments that many working nurses cannot afford.<sup>2</sup> The average ages of doctoral- and master's degree-prepared nurse faculty are 56.8 years and 55 years, respectively.<sup>3</sup> The shortage of nurse faculty will become more pronounced as current nurse faculty retire.<sup>4</sup>

The Nurse Corps SP pays tuition, fees, and other reasonable costs and pays a monthly stipend to individuals attending accredited schools of nursing in exchange for a service commitment of at least 2 years in a CSF after graduation. The Nurse Corps SP reduces financial barriers to nursing

education for all levels of professional nursing students, increasing the pipeline of nurses who serve in CSFs. Qualified applicants who have the greatest financial need<sup>5</sup> receive a funding preference. Tuition and fees are paid directly to the schools while stipends are paid monthly to the students to assist with the cost of books, clinical supplies/ instruments, and uniforms. Stipends were \$1,467.27 per month in 2019. Each participant was eligible to receive \$17,607.24 in yearly stipend support.

The Nurse Corps LRP and SP work together to address the distribution of nurses across the United States through the placement of nurses in CSFs. Many factors affect the supply and demand of the nurse workforce including population growth, aging of the population and the nursing workforce, overall economic conditions, demand for health services broadly and within specific health care settings, and health care reimbursement.<sup>6</sup> A 2017 study projected less growth in the RN supply relative to demand in seven states that could result in regional shortages by 2030.<sup>7</sup> Employers in some parts of the country report difficulty in recruiting and retaining an adequate number of RNs because of an aging RN workforce and a lack of younger RNs to fill the positions.<sup>8</sup> The differences in the age structure of the nursing workforce suggest that action to facilitate workforce development and projections for supply and demand of RNs differ by geographic region.<sup>9</sup>

### III. Overview

HRSA establishes and publishes Nurse Corps program priorities annually in the application and program guidance for each program. In fiscal year (FY) 2019, 50 percent of the Nurse Corps LRP and SP funding was set aside to support NPs. To increase the number of NPs participating in the programs, the Nurse Corps LRP and SP actively recruited licensed NPs and individuals interested in pursuing training as an NP through outreach efforts to colleges, universities, and associations.

For the Nurse Corps LRP, funding preference is given to applicants with the greatest financial need and who are working in Health Professional Shortage Areas (HPSA) with scores of 14 or above.<sup>10</sup> For the Nurse Corps Faculty LRP, a funding preference is given to applicants teaching at schools where at least 50 percent of the student body are from a disadvantaged background.

For the Nurse Corps SP, funding preference is given to applicants with the greatest financial need based on the applicant's Expected Family Contribution (EFC). For FY 2019, this

preference included an EFC between \$0 and \$5,576. Among qualified applicants with the greatest financial need, awards will be made based on consideration of:

- Enrollment or acceptance in an accredited diploma or undergraduate nursing program or an accredited graduate-level NP program, including psychiatric-mental health specialization and full-time or part-time registration for consecutive terms.
- Enrollment or acceptance in an accredited Doctor of Nursing Practice program, a program for certified nurse midwives, certified registered nurse anesthetists (CRNA), clinical nurse specialists, or psychology specialist, and full-time registration for consecutive terms.

This report summarizes the activities of the Nurse Corps LRP and SP for FY 2019, and provides information on:

- Number of enrollees, scholarships, loan repayments, and grant recipients;
- Number of graduates;
- Amount of scholarship and loan repayments made;
- Educational institution attended;
- Number and placement location of Nurse Corps LRP and SP recipients at CSFs;
- Default rate and actions required;
- Amount of outstanding default funds for both the Nurse Corps LRP and SP;
- Reason for default to the extent that it can be determined;
- Demographics of the individuals taking part in the Nurse Corps LRP and SP;
- Justification for the allocation of funds between Nurse Corps LRP and SP; and
- Evaluation of the costs and benefits of the programs.

## **IV. Report Requirements**

### ***Requirement #1: The Number of Enrollees, Scholarships, Loan Repayments, and Grant Recipients***

In addition to awards made with annual appropriations, Nurse Corps made new and continuation Nurse Corps LRP and SP awards with funds recovered from awardees who breached their contracts. Section 846(g)(4) of the PHS Act authorizes X-year funds, the amounts recovered from participants who breach their contracts, to be available and remain available until expended. (Default rates are discussed on page 10.) The programs use the recovered funds to make new awards, continuations, and modifications to the existing contracts. If a Nurse Corps SP participant agrees to a contract for less than the full duration of the training program (e.g., a scholarship covering only the first 2 years of a 4-year bachelor degree program), the participant may request a continuation of the contract in return for a commitment for additional years of support. Nurse Corps LRP participants are eligible for an additional 25 percent of their original verified qualifying outstanding student loan debt in exchange for an additional year of service. Participants requesting continuations must be in good standing with the terms of the initial contract. The programs fund eligible continuations before new awards are made. In FY 2019, the Nurse Corps LRP added \$502,007.79 to its X-year account and Nurse Corps SP added

\$734,230.38. These X-year funds provided 16 awards for Nurse Corps LRP and SP consisting of seven new SP awards and nine LRP new awards (Tables 1 and 2).

HRSA made 853 Nurse Corps LRP awards, including 552 new awards, 292 continuation from annual appropriations, and 9 new X-year funds awards (Table 1). Of the 853 awards, 292 (34.23 percent) were to RNs, 362 (42.44 percent) to NPs, 42 (4.92 percent) to CRNAs, 15 (1.76 percent) to certified nurse midwives, 0 (0 percent) to a clinical nurse specialist, and 142 (16.65 percent) to nurse faculty.<sup>11</sup>

HRSA made a total of 226 Nurse Corps SP awards, including 220 new and 6 continuation awards from annual appropriations. Additionally, HRSA made seven new Nurse Corps SP awards with X-year funds (Table 2). Of those 226 awards, 11 (4.87 percent) were awarded to associate's degree students, 153 (67.70 percent) to bachelor's degree students, and 62 (27.43 percent) to master's degree students.

### ***Requirement #2: The Number of Graduates***

Nurse Corps SP participants may enroll in diploma programs, including accredited associate, bachelor, or master's degree programs. Participants may choose 1 to 4 years of scholarship support, consisting of payment of tuition and fees, other reasonable costs, and a monthly stipend. The minimum service requirement is 2 years of full-time service, with a maximum of 4 years of full-time service in a CSF, depending on the years of academic support received. Nurse Corps SP participants may fulfill their service obligation part time by extending the years of service so

that the aggregate amount of service performed is the full-time equivalent. Nurse Corps SP graduates have up to 9 months from the date of graduation to obtain a nursing license, accept an offer of employment from a program-approved facility, and begin full-time or part-time clinical services at a CSF. There were 217 active Nurse Corps SP participants who graduated in FY 2018.<sup>12</sup> Of those Nurse Corps SP participants, 200 were serving in a CSF, 2 were pursuing further training in nursing residency programs, and 15 were waiting for their placement at a CSF. In FY 2019, there were 197 Nurse Corps SP graduates from accredited school programs (Appendix A). As of September 30, 2019, 65 were serving in a CSF, 4 were pursuing further training in nursing residency programs and 128 were actively seeking employment.

***Requirement #3: The Amount of Scholarship Payments and Loan Repayments Made***

For amounts paid for Nurse Corps LRP and SP new awards and continuations, funded from annual appropriations (base funds) and X-year funds, see Table 3.

***Requirement #4: The Educational Institutions Attended by Recipients<sup>13</sup>***

Nurse Corps SP participants attended 218 schools in 40 states, the District of Columbia and Puerto Rico. Appendix B illustrates the distribution of FY 2019 new awards by state and educational institution at 137 schools in 36 states, the District of Columbia and Puerto Rico.

***Requirement #5: The Number and Placement Location of the Scholarship and Loan Repayment Recipients at Healthcare Facilities with a Critical Shortage of Nurses***

Non-nurse faculty Nurse Corps LRP and SP participants are required to serve at a CSF. In 2019, private entities were not eligible for placement of Nurse Corps LRP participants, unless the entities are non-profit. Nurse Corps SP participants were permitted to serve at private, for-profit entities. The CSF definition requires facilities to be in, designated as, or serving a primary care

or mental health HPSA. The following types of facilities are eligible CSFs for placement of Nurse Corps LRP and SP participants:

- Critical Access Hospital,
- Disproportionate Share Hospital,
- Public hospital,
- Federally Qualified Health Center,
- Indian Health Service Health Center,
- Native Hawaiian Health Center,
- Rural Health Clinic,
- Skilled Nursing Facility,
- State or local Public Health or Human Services Department,
- Free and charitable clinic,
- Ambulatory surgical center,
- Home health agency,
- Hospice program,
- Non-Disproportionate Share Hospital, and
- Nursing home.

In FY 2019, 501 Nurse Corps LRP participants served in 409 CSFs in 45 states, the District of Columbia, and Puerto Rico (Appendix C); and 60 newly-awarded participants served as nurse faculty in 58 schools of nursing in 36 states (Appendix D).

### ***Requirement #6: Default Rate and Actions Required***

The Nurse Corps LRP and SP default rates<sup>14</sup> are expressed as the percentage of participants in a cohort (all participants with a new or continuation contract awarded in a FY) who default (number of participants who have defaulted divided by the total number of individuals in the cohort). Individuals often participate for multiple years; however, default rates are calculated in the FY in which an individual received the initial award. Therefore, for any given cohort, the default rate for a FY may change over time. When participants are out of compliance with their service obligation, they are referred to HRSA's Division of Participant Support and Compliance for compliance assistance. If the participant does not come into compliance and defaults, the Division of Participant Support and Compliance refers the participant to the Program Support Center for debt collection.

The maximum years a participant in full-time service may be in the Nurse Corps SP is 8 years—4 years in school and 4 years of obligated service. The maximum number of years that a participant in full-time service may be in the Nurse Corps LRP is 3 years—2 years of service under an initial contract and one additional year of service under a continuation. Participants with periods of approved suspension of service may require an additional 1 to 2 years of monitoring. Participants wishing to serve part-time must obtain prior approval from Nurse Corps and must extend the service obligation to equal the full-time commitment. Thus, default rates are reported over 10 years for the Nurse Corps SP and 5 years for the Nurse Corps LRP to

provide an accurate picture of default rates. Historically, few to no defaults occur within the first year of the service obligation.

Participants who breach their contracts are placed in default and are liable to repay the Nurse Corps LRP or SP funds they received, plus interest, from the date of the default which is the date the participant breached the Nurse Corps contract service obligation or, for scholars, the date they left their educational program as described in section 846(g)(1)(A). The total amount owed, including interest, must be paid within 3 years of the date of default. The interest rate is the maximum legal prevailing rate for the applicable quarter determined and fixed by the Secretary of the Treasury after taking into consideration private consumer rates of interest. Nurse Corps LRP and SP work with participants placed in default by helping them to satisfy their debts through service when possible. In FY 2019, eight defaulted participants returned to service—one Nurse Corps LRP participant and seven Nurse Corps SP participants.

As of September 30, 2019, there were 204 defaults in the Nurse Corps SP from FY 2010 to FY 2019.

***Requirement #7: Amount of Outstanding Default Funds of Both the Loan Repayment and Scholarship Programs***

Section 846(g)(4) of the PHS Act authorizes amounts recovered (X-year funds) from participants who breach their Nurse Corps LRP or SP contract to be made available for the respective program until expended. X-funds are used for new awards, continuations, and modifications to existing contracts. In FY 2019, the Nurse Corps LRP added \$502,007.79 to its X-year account providing nine new awards, and closed the FY with a net X-year accumulation of \$24,238.49. In FY 2019, the Nurse Corps SP added \$734,230.38 to its X-year account providing seven new awards, and closed the FY with a net X-year accumulation of \$144,416.91.

As of September 30, 2019, the total outstanding default debt was \$3,223,236.30 for the Nurse Corps LRP and \$14,063,538.10 for the Nurse Corps SP.

***Requirement #8: The Reasons for the Default***

The most common reasons for default in the Nurse Corps SP are that participants fail to complete their service obligation, withdraw from school, or receive an academic dismissal.

***Requirement #9: The Demographics of the Individuals Participating in the Loan Repayment and Scholarship Programs***

Nurse Corps LRP and SP participants self-report demographic data. Of the participants who reported on sex, race, and ethnicity, the majority were female and White, with Black or African-American the largest minority group (Table 8). HRSA requests Hispanic/Latino and Non-Hispanic/Non-Latino ethnicity data in the electronic application separately from gender and race data. Applicants may choose to report on any of these demographic areas in whole or in part. As a result, Hispanic/Latino and Non-Hispanic/Non-Latino data may be over-reported as this information is the only metric for capturing ethnicity.

***Requirement #10: Justification for the Allocation of Funds between the Loan Repayment and Scholarship Programs***

Historically, total Nurse Corps funds have been allocated at 67-75 percent for the LRP and 25-33 percent for the SP. For FY 2019, \$86.7 million was appropriated for the Nurse Corps LRP and SP. Of the \$86.7 million, HRSA allocated \$76.9 million for the Nurse Corps LRP and SP, with the remaining \$9.9 million directly supporting the Nurse Corps programs in the form of staffing and acquisition contracts including the electronic system used to process program applications and monitor awarded participants, as well as tax withholding and reporting and other administrative obligations. Of the \$76.9 million, HRSA allocated over 68 percent (\$52.6 million) to the LRP and nearly 32 percent (\$24.3 million) to the SP. The combination of these programs allows flexibility in meeting the future needs through the Nurse Corps SP pipeline of nurses and the immediate needs through the Nurse Corps LRP, which places nurses in the field immediately.

## ***Requirement #11: An Evaluation of the Overall Costs and Benefits of the Programs***

### Analysis of Costs per Years of Service

#### 1. FY 2019 Nurse Corps LRP Awards

In FY 2019, HRSA made 561 new awards, an increase of 3 percent compared to the 544 new awards in FY 2018. The average new award amount for Nurse Corps LRP participants was \$77,771.16 for non-faculty and \$71,231.58 for nurse faculty. This is a 5 percent decrease in the average new award amount for non-faculty participants. This is an 11 percent decrease in the average new award amount for nurse faculty participants from FY 2018 to 2019.

#### Nurse Corps LRP Continuations

In FY 2019, 51 percent of the participants initially awarded in FY 2017 requested a continuation award. The Nurse Corps LRP awarded 292 continuations in FY 2019. Nurse faculty received 28 percent (82 awards) of the continuation awards.

#### 2. FY 2019 Nurse Corps SP Awards

In FY 2019, Nurse Corps SP made 220 new awards and 6 continuation awards. The average new award was \$106,034.84—a 5 percent increase in the number of new awards and a 9 percent decrease in the average new award amount from FY 2018 to FY 2019.

#### 3. Average Amount Funded per Year of Service Obligated

Nurse Corps LRP new awards are based on 2 years of obligated service and capped at 60 percent of the applicant's total eligible loan amounts. The average new LRP award amount per year of obligated service was \$38,885.58 for nurses serving in CSFs and \$35,615.79 for nurses serving in accredited schools of nursing—a 5 percent decrease and an 11 percent increase respectively, from FY 2018 to FY 2019.<sup>16</sup>

Nurse Corps SP awards are based on 1 year of service for each year of funding with a minimum of 2 years of service. The average new SP award amount per year of obligated service was \$50,837.28—a 3 percent decrease from FY 2018 to FY 2019.

## **V. Conclusion**

The Nurse Corps LRP and SP continue to work towards increasing the number of nurses working in CSFs across the United States. Through the efforts and accomplishments highlighted

in this report, dedicated RNs and APRNs can care for underserved populations in CSFs and provide quality education in schools of nursing with students from disadvantaged backgrounds.
